**STEP TWO:**

1. Submit a signed copy of your 2020 IRS tax return (*Form 1040 & Schedules 1-3 as applicable*)
2. Submit the three most recent payroll advices (pay stubs) for 2021 (*as applicable*)
3. Provide a personal narrative (typed) of chronological events including significant dates that correspond with third party documentation and a physical signature.
4. Provide other third party documentation of personal circumstances that address your economic hardship beyond your control.
