



Nursing Assistant I Program

Prerequisite Completion Process:

VISIT: [Davidson Davie Nursing-Assistant 1 Program](#)

To be cleared to enroll, students must complete the following:

- 1) Complete program Interest form by visiting <https://www.davidsondavie.edu/nursing-assistant-i-program-interest-form/>
 - Must upload proof of reading requirement by providing **ONE** of the following:
 1. An official or unofficial high school transcript if a student graduated within the last 5 years and has an unweighted GPA of 2.6 or higher.
 2. SAT score report indicating a 480 or higher in Evidence-Based Reading and Writing.
 3. ACT score report of 22 or higher in Reading or 18 or more in English.
 4. Score at least 10.0 on the CASAS* reading placement test.
 5. An official or unofficial transcript indicating completion of a college-level English course.

Please note: Students that need the CASAS reading placement test will be issued a testing permission form after completing the program interest form. <https://www.davidsondavie.edu/nursing-assistant-i-program-interest-form/>

- 2) Immunizations are required **BEFORE** students are cleared to register for class.

Criminal Background Check & Drug Screening:

- Background checks are conducted through [COMPLIO](#) and include social security trace, nationwide criminal, OIG, and sex offender search, as well as statewide criminal search.
- A 12-panel urine drug screen must be obtained from an approved lab with [COMPLIO](#).
- We **do not** accept outside background checks or drug screens, including Complio accounts from previous college programs.

Additional Requirements:

- Computer and internet access **is required** for all NAI classes.
- Students must be 17 years of age when class begins.
- Class and clinical attendance is mandatory.
- CPR certification is included in the class and required to be taken by all students **even if they hold a current CPR certification**.
- Lab and clinical times and locations may vary from your class schedule. You will need to have a flexible schedule. Refunds will not be issued past the census date of the course.
- You may be dismissed for attendance violations from class and clinical.
- The physical demands include but are not limited to the following:
 1. Walking/standing for 4-6 hours
 2. Bending, pushing, pulling, or lifting up to 25 lbs.
 3. Assisting residents safely from bed to wheelchair, moving in bed and walking.
 4. Assisting with mechanical lifts

Disclosures:

As a student enrolled in a healthcare training program with Davidson-Davie Community College, you understand that you must complete a clinical field experience with an outside agency as arranged by the college. You further understand, your assigned agency or agencies may have requirements that may differ from those of the college, and that you must meet these requirements to participate in the clinical field experience. **Requirements may include but are not limited to criminal background checks, use of specific personal protective equipment (PPE), and specific vaccinations, including those specifically targeted at COVID-19 and/or Influeza (Flu).** Failure to meet these clinical stipulations will prevent you from successfully completing program requirements and will result in you being withdrawn from the program. Davidson-Davie Community College will provide direction on the specific requirements for the agencies that are current at the time of enrollment, but you understand that these may change before you reach the clinical experience. In that event, Davidson-Davie Community College will provide direction on meeting the requirements and suggest opportunities, if any, to meet any updated requirements. The student will not be entitled to a refund beyond the census date.

Immunizations:

Upload proof of immunizations to [COMPLIO](#) for review. These are required for entry into the program. Records can be obtained from a local Health Department, Primary Care Physician (PCP), or healthcare provider. Letter of exemptions must be uploaded onto Complio for approval. Medical exemptions must be written by a physician on a letterhead and uploaded to Complio for approval. **Note:** Exemptions are processed in accordance with and based upon the policies of clinical facilities; therefore, exemptions are not guaranteed.

Cost Breakdown:

Before class Entry:

- Tuition and Fees **\$199.50 – Due at time of registration to reserve seat in class**
- Criminal Background and Drug screen plus NA1 tracking package- \$97.00 [COMPLIO](#)
- Immunizations up-to-date (*costs vary*) - **due before class registration**

Purchase for Day 1 of class:

1. Student Course Packet **\$52.87 – purchase at [Online Bookstore](#)** (*cost subject to change*)
2. Manual Blood Pressure Cuff (*costs vary*)
3. Stethoscope (*costs vary*)
4. Ciel blue colored scrubs (*costs vary*)
5. White or black non-skid leather shoes (*costs vary*)
6. Watch with second hand (*no electronic watches - costs vary*)
7. **Must have valid photo ID and a social security card - [proper ID](#)**
 - a. *Photocopies of identifications will not be accepted.*
 - b. *Name listed on the identifications must be the same.*

Last Day of Course:

1. Testing Fee **\$140.00 - fee paid to Credentia state-approved testing agency (credit card/prepaid card only)**
 - a. Students register independently after meeting all course requirements.
